RULES FOR PARTICIPATION FOT THE TECSAMS' NETWORK MENTAL HEALTH INNOVATION CONTEST WITHIN THE FIRST MENTAL HEALTH INVESTMENT FORUM

About the TECSAM Network

The Innovation Network of New Technologies in Mental Health (TECSAM) brings together 57 Catalan research groups from 29 institutions in the field of technology and mental health.

The TECSAM Network aims to generate internal and external synergies, as well as to implement valorization and transfer strategies in order to accelerate the arrival to the society of the results from the research groups.

It counts on the participation of associations of people with mental health problems and their families, foundations and other public and private entities that are crucial in the innovative ecosystem, such as innovation hubs, clusters, venture capital, accelerators and incubators, among others. This project has been co-financed by the European Union through the European Regional Development Fund (ERDF-FEDER) and is now co-financed by the Departament de Recerca i Universitats of the Generalitat de Catalunya.

In 2024, the TECSAM Network is launching its first Mental Health Investment forum, together with BHV as partners.

About the TECSAM Network Mental Health Innovation Contest within the First Mental Health Investment Forum

CATEGORIES AND PRIZES

There will be one category with two winners' award:

1. Research projects

Two projects will be awarded with a mentoring program and the activation of TECSAM's ecosystem to help the project reach society and the market.

- First prize: "BHV mentoring program" valued in 5.000€
- Second prize: "Venture Capital mentoring" valued in 1.000€

Only applications belonging to members of the TECSAM network that are participating in the "Entrepreneurships training" organized by TECSAM and BHV will be selected. Projects that are willing to participate in the investment forum but did not conduct the "Entrepreneurship training", will have the opportunity to apply as a project/start-up/spin-off in the "open call" category.

Prior to the selection of the winners, 5 finalists will be designated. Each finalist will present their pitch in the Mental Health Innovation Contest of Xarxa TECSAM within the First Mental Health Investment Forum.

The winners will be announced on the 12th of June during the Mental Health Investment Forum.

PARTICIPATION PROCESS

- 1. Candidates **must be registered and conducting the "Entrepreneurship training"** organized by TECSAM and BHV.
- 2. Candidates will be selected during the "Entrepreneurship training", and the selected projects will undergo the preparatory pitch sessions (07/06/2024)
- 3. The 5 selected projects will participate in the pitch for the TECSAMs' Network Mental Health Innovation Contest within the First Mental Health Investment Forum on June 12th.
- 4. The TECSAM Network Coordination Team holds the right to change both dates with prior notice.

5. Visual material for the pitches **must be submitted in English**, although the oral presentation can be done either in Spanish, Catalan or English.

DEADLINES AND MILESTONES

21/03/2024: Inscription for the "Entrepreneurship training by BHV" are open

17/05/2024: Last session of the "Entrepreneurship training"

21/05/2024: communication of the selected projects who will be invited to the "Pitch preparation session"

07/06/2024: "Pitch preparation session" to select the 5 finalists who will participate in the "TECSAMs' Network Mental Health Innovation Contest" within the "First Mental Health Investment Forum". The 5 finalists will be communicated the same 7th of June, after the "Pitch preparation session".

12/06/2024: Pitches of the TECSAMs' Network Mental Health Innovation Contest within the First Mental Health Investment Forum

- All pitches must have a **maximum duration of 15 minutes** (10min for the presentation and an extra 5min for Q&A)
- Jury evaluation and selection of winner
- Prizes delivery

The TECSAM Network Coordination Team holds the right to change the dates with prior notice.

SELECTION PROCESS

The selection process of the projects for the TECSAMs' Network Mental Health Innovation Contest will be as follows:

- 1. An internal committee (composed by BHV and TECSAM members) will evaluate the potential candidates which are participating in the <u>"Entrepreneurship training"</u> organized by TECSAM and BHV to attend the "Pitch Preparation Session". Extra information could be requested if required.
- 2. An external committee and Jury (composed by one BHV team member, one communication and pitch expert, one entrepreneur, and one member of the TECSAM Network) will evaluate the potential candidates during the "Pitch preparation session".
- 3. The 5 finalists will pitch their projects in front of a jury during the First Mental Health Investment Forum. The jury will then review in accordance with the evaluation criteria. This panel of external evaluators will be composed by: one BHV team member (different from the previous committee), one entrepreneur,

- one consultor, one venture capital investor, and one member from the TECSAM Network.
- 4. The result of the jury evaluation will be notified to the applicants during the same Investment Forum.

ELIGIBILITY CRITERIA

The requirements for an application to be a candidate for the **TECSAMs' Network Mental Health Innovation Contest** in the First Mental Health Investment Forum of the TECSAM Network are:

- 1. Personal commitment (either from the person submitting the application form or from another member of the team) to follow through and present the pitch during the "Investment Forum".
- 2. Only groups belonging to members of the TECSAM network that are participating in the "Entrepreneurships training" organized by TECSAM and BHV will be considered.
