# TECSAM NETWORK SECOND MENTAL HEALTH INVESTMENT FORUM

### About the TECSAM Network

The Innovation Network of New Technologies in Mental Health (TECSAM) brings together 57 Catalan research groups in the field of technology and mental health.

The TECSAM Network aims to generate internal and external synergies, as well as to implement valorization and transfer strategies in order to accelerate the arrival to the society of the results from the research groups.

It counts on the participation of associations of people with mental health problems and their families, foundations and other public and private entities that are crucial in the innovative ecosystem, such as innovation hubs, clusters, venture capital, accelerators and incubators, among others. This project has been co-financed by the European Union through the European Regional Development Fund (ERDF-FEDER) and is now co-financed by the Departament de Recerca i Universitats of the Generalitat de Catalunya.

In 2025, the TECSAM Network is launching its second (II) Mental Health Investment forum.

# About the TECSAM Network Second (II) Mental Health Investment Forum

#### CHALLENGES TO ADDRESS

The investment forum aims to attract entrepreneurs, investors and solutions in the mental health and brain science field, to **bring these solutions closer to the society and unite the mental health entrepreneur ecosystem** in a unique forum.

#### **CATEGORIES**

There will be one category:

1. Open call

The 5 selected projects/start-ups will have the opportunity to present their pitch in the "Second Mental Health Investment Forum" (3/11/2025). The 5 selected projects/start-ups will be announced Tuesday 16<sup>th</sup> of September.

#### PARTICIPATION PROCESS

The call for projects will be open from 2nd of July until the 10th of September.

- 2. Applications will be accepted until the 10<sup>th</sup> of September 2025 at 12:00 PM.
- 3. All participants will be notified whether they have been selected as candidates by the 16<sup>th</sup> of September. 5 projects/start-ups will be selected.
- 4. Pitch within the Mental Health Investment Forum: on Monday 3<sup>rd</sup> of November, the 5 selected projects/start-ups will present their pitch during the main event at the Investment Forum. Time slot will be provided at least one week prior to the event.
- 5. The TECSAM Network Coordination Team holds the right to change both dates with prior notice.
- 6. Applications must be submitted in English on the aforementioned form.

#### DEADLINES AND MILESTONES

02/07/2025: Applications for the SECOND MENTAL HEALTH INVESTMENT FORUM are open

10/09/2025: Deadline for applications

16/09/2025: selection of the 5 projects/start-ups that will present their pitch

#### 3/11/2025: Pitches in the Second Mental Health Investment Forum

- Selected start-ups and companies will pitch during the Second Mental Health Investment Forum.
- All pitches must have a **maximum duration of 15 minutes** (10min for the presentation and an extra 5min for Q&A)
- All the presentations (support materials or slides) must be in English;
  although the oral presentation can be done in Catalan, Spanish or English.
- The TECSAM Network Coordination Team holds the right to change the dates with prior notice.

#### SELECTION PROCESS

The selection process of the start-ups for the Second Mental Health Investment Forum will be as follows:

- 1. An internal committee (composed by TECSAM members and a steering committee) will evaluate the applications to ensure they meet the eligibility criteria. Extra information could be requested if required.
- 2. The result of this evaluation will be notified to the applicants, as well as whether their application was accepted.
- 3. The 5 finalists will get to pitch their projects during the Second Mental Health Investment Forum.

#### **ELIGIBILITY CRITERIA**

The requirements for an application to be a candidate for the Second Mental Health Investment Forum of the TECSAM Network are:

- 1. Personal commitment (either from the person submitting the application form or from another member of the team) to follow through and present the pitch during the Mental Health Investment Forum.
- 2. The application submitted needs to be aligned with the nature of the call.
- 3. Only projects/start-ups in the mental health or brain science field will be considered.
- 4. Applications should comply with the extension limits for each question.
- 5. Applications and visual materials **must be in English**; although pitch speech can also be done in Catalan or Spanish.

# Acceptance of the Rules

Participation in the Second Mental Health Investment Forum entails full and unconditional acceptance of these Rules. Recognition as a valid participant is subject to compliance with the requirements set forth in these Rules.

## Assignment of the right to use the image

Applicants irrevocably and free of charge authorize the TECSAM Network and Parc Sanitari San Joan de Déu, as coordinator and within the framework of the Second Mental Health Investment Forum activities, to make use, reproduce, edit, and exploit, in whole or in part, or broadcast their full or partial name as well as their image, in any publicity or advertisement made through any media or format, whether written, audio-visual or internet, for the maximum period permitted by law, worldwide, in relation to participation in the Second Mental Health Forum for the purpose of promotion, information and advertising of the Second Mental Health Forum and the TECSAM Network.

Likewise, the participant guarantees that the data provided are accurate and truthful.

Participants may exercise their rights of access, rectification, cancellation and opposition, under the terms provided in the data protection regulations.

The TECSAM Network undertakes to treat your personal data confidentially at all times and in accordance with the purposes set out in this clause and Rules; to adopt the necessary technical and organizational measures to ensure the security of your data and avoid its alteration, loss, unauthorized access or processing, given the state of technology, the nature of the data stored and the risks to which they are exposed, all in compliance with the provisions of the data protection regulations in force at all times.

In case of providing your data, we will understand that you authorize us to process them according to the above.

#### Modification of the Rules

The TECSAM Network reserves the right to modify at any time the Rules, without assuming any responsibility for these modifications, provided that there is justified cause, due to force majeure or circumstances beyond the control in a way that does not prejudice the rights acquired by the participants, committing to communicate with sufficient notice the new conditions of participation.

# Extension or suspension of the Second Mental Health Investment Forum

The TECSAM Network reserves the right to be able to extend the deadline, properly communicating this change. In addition, the TECSAM Network reserves the right to suspend the Second Mental Health Investment Forum for good cause or force majeure and in the event that it could not be developed by fraud detected, technical errors, due to lack of participation or problems of any other nature that are not under the control of the TECSAM NETWORK and may affect its normal development.
